1 Purpose of this NPRM

The purpose of this NPRM is to consult with the industry before promulgating MCAR-13A Aircraft Accident and Incident Investigation.

2 Background to the Proposal

This NPRM is issued in order to inform and consult the industry about the changes which has been brought to MCAR-13A.

The changes have been to migrate accident investigation requirements specified in MCAR-12 to this regulation, remove the requirements related to search and rescue from this regulation and to comply with ICAO Annex 13, twelfth Edition issued on 20 July 2020.
